Section 3-Hazards Identification

Emergency Overview

Danger! Strong oxidizer. Contact with other material may cause fire. Harmful if swallowed or inhaled. Affects central nervous system, liver and kidneys. May cause irritation to skin, eyes, and respiratory tract.

Potential Health Effects

Eye contact : May cause irritation, redness and pan.

Skin contact: Possible irritation or reddening of moist skin on prolonged contact.

Ingestion : May cause gastrointestinal upset with symptoms of abdominal pain, vomiting, and diarrhea. Animal experiments suggest a potential for kidney and blood cell damage, similar to that of the bromates and chlorates.

Inhalation : May irritate the respiratory tract, with symptoms of coughing and possible shortness of breath.

Chronic Exposure: Repeated ingestions may cause kidney dysfunction of failure and blood conditions such as hemolysis. Central nervous system may be affected.

Aggravation of Pre-existing conditions: Persons with impaired liver or kidney function may be more susceptible to the effects of this substance.



Section 4-First Aid Measure

Inhalation: Remove to fresh air. Get medical attention for any breathing difficulty.

Ingestion: Induce vomiting immediately as directed by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention.

Skin Contact: Immediately flush skin with plenty of soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention if irritation develops.

Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes, lifting upper and lower eyelids occasionally. Get medical attention if irritation persists.

Section 5-Fire fighting procedure

Fire: Not combustible but enhances the combustion of other substances. Strong oxidizing agent. Can release gaseous oxygen when heated.

Explosion: May explode when exposed to mechanical shock or friction or can cause explosions with combustible materials. Sensitive to mechanical impact.

Fire Extinguishing Media: Use water spray to blanket fire, cool fire exposed containers, and to flush non-ignited spills or vapors away from fire.

Special Information: In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full facepiece operated in the pressure demand or other positive pressure mode. Water spray may be used to keep fire exposed containers cool.

Section 6-Accidental Release Measure

Remove all sources of ignition. Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Spills: Clean up spills in a manner that does not disperse dust into the air. Use non-sparking tools and equipment. Reduce airborne dust and prevent scattering by moistening with water. Pick up spill for recovery or disposal and place in a closed container. Dike and cover spill with ferrous sulfate, sodium sulfite or sodium thiosulfate, then moisten and acidify, if necessary, to promote the reduction reaction. Neutralize slurry with soda ash.

Section 7-Handling and Storage

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage and moisture. Isolate from any source of heat or ignition. Avoid storage on wood floors. Separate from incompatibles, combustibles, organic or other readily oxidizable materials. Containers of this material may be hazardous when empty since they retain product residues (dust, solids); observe all warnings and precautions listed for the product.



Section 8-Exposure control/Personal protection

Airborne Exposure Limits: None established.

Ventilation System: A system of local and/or general exhaust is recommended to keep employee exposures as low as possible. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its source, preventing dispersion of it into the general work area. Please refer to the ACGIH document, *Industrial Ventilation, A Manual of Recommended Practices*, most recent edition, for details.

Personal Respirators (NIOSH Approved): For conditions of use where exposure to dust or mist is apparent and engineering controls are not feasible, a particulate respirator (NIOSH type N95 or better filters) may be worn.
